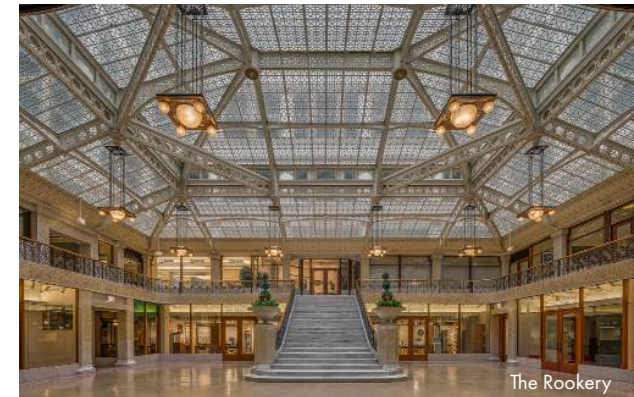

In the years 2023 and 2024, the Trust observed the centennial of Wright's 1923 Imperial Hotel, celebrated 50 years since our 1974 founding, conducted major restoration projects at Wright's Home and Studio made possible by the Goshorn/Schumann Trust, completed rehabilitation of our Resource Center, created new destinations in our travel program, expanded education offerings, and reached \$7.5 million toward its \$12.5 million goal for a learning center.

Making Trust sites and resources accessible to a broad audience has been an ongoing effort during 2023-24. In the summer of 2023, guests representing the Imperial Hotel, Japanese diplomatic service, and the Japanese tourism industry gathered at Robie House to reaffirm the Trust's long relationship with Japan, a signature destination of our travel program for over twenty years.

Board Chairman John Rafkin read a message from Rahm Emanuel, U.S. Ambassador to Japan and former Mayor of Chicago. Speeches recognized the uniquely Japanese characteristics of the house familiar to thousands of Japanese guests who have visited since 1997 when the Trust opened Robie House as a public museum. A gift of two cherry trees to the Robie House courtyard garden by the Imperial Hotel, Ltd. commemorated the centennial of Wright's original 1923 Imperial Hotel, which survived the great Kanto earthquake on the day of its opening in Tokyo.



In 2023, the Frank Lloyd Wright Trust partnered with the Imperial Hotel, Ltd. to celebrate the centennial of Wright's Imperial Hotel in Tokyo. The 100-year celebration was marked by a gift of cherry blossom trees from the Imperial Hotel, Ltd. for the Robie House courtyard garden.

In the summer of 2024, the Trust observed its jubilee - 50 years since its founding. A celebration dinner was presided over by Trust founding president, Dawn Schumann, and several founding members of the Board returned to Oak Park for the occasion. Volunteers were recognized with service awards ranging from five to fifty years. To honor and recognize all volunteers who have served the Trust, a complete roster of volunteer names from 1974 to the present was established on the Trust website as a permanent record of all who have volunteered their time and talent to the Trust. The list contains more than 3,000 names.

An exhibition titled *Photographing Frank Lloyd Wright* opened at the Driehaus Museum in fall 2024. An important lender to the exhibition, the Trust was also the exhibition's program partner participating in an opening panel discussion with guest scholars, partnering with the museum on photography workshops and programs for educators, and offering tours of Robie House in conjunction with tours of the exhibition. Visitation of over 100,000 expanded awareness of the Trust to new cultural audiences.

The Trust's Travel Wright program created two new destinations for the Trust's 50th anniversary. *Italian Interlude: Wright in Fiesole* introduced travelers to Tuscany where Wright spent time away from the U.S. in 1909-10 living at *Villino Belvedere* in the beautiful Italian countryside. *Divine Nature: Wright in the American South* traveled to Bentonville, Arkansas to experience the work of E. Fay Jones, a renowned architect and close associate of Wright, and to see the amazing Crystal Bridges Museum of American Art which includes in its collection Frank Lloyd Wright's Usonian classic, the Bachman-Wilson House. Both trips sold out in a record three days and will now become part of Travel Wright's regular offerings.

The Trust's education programs expanded during 2024 to include three *Teaching by Design* Educator workshops and two new *Evenings for Educators* programs, and *In Wright's Studio* weeklong summer camps for kids. Teachers' programs took place at multiple sites, including the Driehaus Museum, The Rookery, and Robie House, exposing educators to a range of historic architectural settings to explore. *In Wright's Studio* summer camps introduced campers to Doug Freerksen, a veteran preservation professional working at the Home and Studio site. Doug shared stories and showed examples of preservation in action that inspired the design projects the campers created.

During 2023 and 2024, tour and program operations grew in strength and numbers with 110,000 guests in 2023 and 120,000 in 2024. Virtual visitation expanded decisively with 535,000 website visitors in 2023 and 590,000 in 2024. Grant revenue exceeding \$600,000 supported programs and operations with over \$2 million supporting the Learning Center expansion.

The sold-out *Wright Plus* 2023 event was led by co-chairs Sue Blaine and Joan Pantsios. The Arthur and Grace Heurtley House was the signature home. *Wright Plus* 2024 was again a sold-out event and featured the Emma S. and Peter A. Beachy House as its signature home. Joan Pantsios concluded her two-year tenure as *Wright Plus* co-chair and Debbie Crouch served the first of her term. With multiple new and returning sponsors, the combined revenue for 2023 and 2024 *Wright Plus* and Ultimate Plus totaled \$375,000.

Annual Appeal and the *Wright Night* holiday events of 2023 and 2024 totaled \$460,385.

Hosted by the Board of Directors, *Wright Night 2024* celebrated the Trust's 50-year anniversary with guests enjoying a 50-year toast, a superb silent auction, and a program update on preservation, education, and the Learning Center.

A 2023 gift of \$300,000 from the Goshorn/Schumann Trust for the preservation of the Home and Studio initiated over two years of preservation projects at the site. Beginning with a new wood-shingle roof that will last 50 years, additional work at the Home and Studio included rebuilding the skylight over Wright's study and tuck-pointing chimneys over the Studio.

Concurrent with this project was the exterior and interior refurbishment of the Jane and John Blair House, nicknamed "Anna's." It was John Blair who sold Wright the property for his Home and Studio and sold his own post-Civil War house to Wright's mother Anna. The original house, dating to 1866-67 numbers among the oldest homes in Oak Park. Multiple additions were added to the house over the decades. Some awkward later additions were removed as part of the refurbishment, returning the house to its late 1920s integrity, the era after Anna Wright sold the house in 1920 and moved out.

In addition to a new wood-shingle roof and tuck-pointing the chimney, the house was completely repainted with interior rooms recarpeted and new lighting installed. An ADA bathroom was installed in the back foyer of the home and balusters on the front porch were replaced to meet current ADA requirements.

As the Trust set the stage for a new Learning Center consisting of a Resource Center at 925 Chicago Ave. and a Studio Pavilion at 929 Chicago Ave., adequate funding was secured to complete work at the Resource Center, which includes a Frank Lloyd Wright Reading Room, archive, and work center for education. State of the art fire and security systems protect the building and a beautiful ADA ramp in back (pictured on the cover of this report) serves as the main entrance for public use. The south foyer entrance includes an ADA wash-room. Trust outdoor events and programs will take place on the back patio and yard until the new pavilion, which will complete the learning center, creates fully equipped indoor program and studio space.

During 2023-2024, the Trust marked 50 years of dedication to our mission and began an expanded 21st century era of public access and accessibility to our sites, resources, and programs - all dedicated to life-long learning and the architecture, design, and American cultural legacy of Frank Lloyd Wright. With more than half of the required funding in place and the Studio Pavilion ready for construction, the stage is set for completion of the Learning Center.

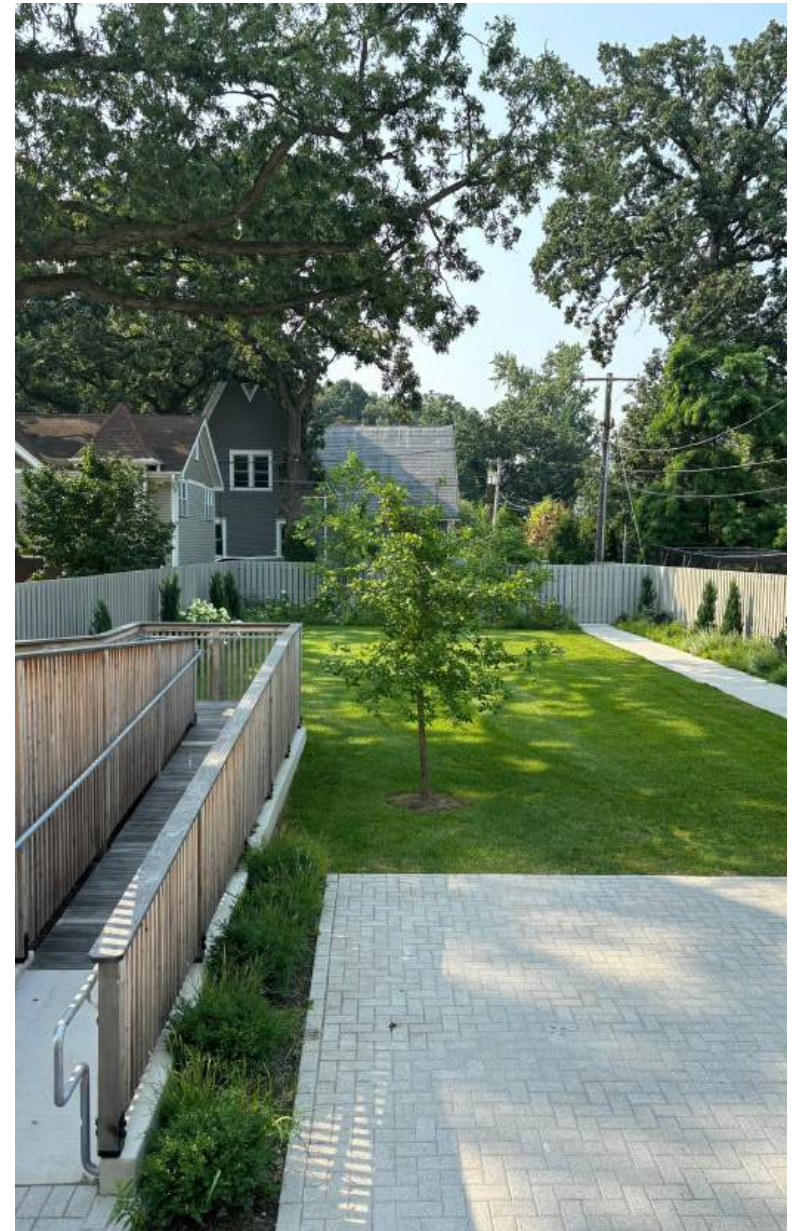
